The appellant states that PIO has assured him that the remaining information within two / three days' time. On that context the appellant prayed for closure and dispose of this appeal case.

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing the parties and perusal of the records observes that most of the information sought has already been furnished to the appellant. The appellant was satisfied with information furnished to him and on assurance from the PIO to furnish the remaining information within 2 / 3 days he prayed for closure of this appeal case.
