**Information sought :**

The appellant file a RTI Application dated 04/07/2024 seeking Details regarding submission of works Methodology-Road alignment plan, L-cross section,, Drawing of Culverts, CC Drainage, Bridges, 62kmsubmitted by M/s PRL Project& infrastructure Ltd. M/s Gepong (JV).

As per the case record, PIO has conducted the hearing under his jurisdiction on 01/08/2024.

Being dissatisfied, the appellant filed First Appeal dated 12/08/2023. First Appellate Authority has conducted hearing on 16/09/2024. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Techi Hemu on **04.07.2024** filed an RTI application under Form-'A' before the PIO-cum-Supdt. Engineer (HQ), Western Zone (PWD), Itanagar, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **12.08.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **24.09.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 253/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two time i.e on 09/12/2024 and 03/02/2025. In this hearing of the appeal on 3<sup>rd</sup> day of February, 2025, the PIO present in person and filed an affidavit on declaration of non-availability of the document/information as sought by the appellant before the Commission today as per the order passed by the Commission on 09/12/2024. But the appellant is found absent without any intimation to the Commission.

In consideration of the declaration submitted by the PIO, the Commission deems that the information sought is not available with the PIO and accordingly the appeal case No. APIC-253/2024 is disposed off and closed once for all.


