Information sought :

The appellant file an RTI Application dated 21/06/2024 seeking Details regarding Cultivation of Ginger at Namsai District.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 09/08/2024. The First Appellate Authority has conducted the hearing on 29/08/2024. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Tamchi Gungte absent

Respondent : PIO-cum-DAO, Namsai District is represented by Shri Lenzing Dai, APIO.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gungte on **21.06.2024** filed an RTI application under Form-'A' before the PIO-cum-District Agriculture Officer, Namsai District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **09.08.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **10.09.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 301/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two times i.e on 12/03/2025 and 16/04/2025. In this hearing of the appeal on 16th day of April, 2025, the PIO-cum-District Agriculture Officer, Namsai is represented by Shri Lenzing Dai, APIC through VC but the appellant Shri Tamchi Gungte found absent without any intimation to the Commission.

During the hearing the PIO stated that all the information as sought by the appellant has already been furnished through postal services. A forwarding letter of the information furnished to the appellant has been submitted to this Commission.

As per the case record, on the last hearing dated 10/3/2025 the appellant was found absent and he was ordered to be present before the Commission and if he found absent, the appeal case will be disposed off in his absence.

Today the appellant is absent for second time. Moreover, the PIO has intimated that the information required by the appellant has already been provided. Therefore, the Commission deems that appellant has received all the information from the PIO and is satisfied and is no more interested to pursue the appeal case.

Therefore, the Commission is inclined to dispose off and close the appeal case in absence of the appellant. The appeal case No. APIC-245/2024 is closed once for all.
