O R D E R

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Sama Bagang, Forest Colony quarter Type-I, Chimpu Police Station, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (E), Capital Electrical Division, Department of Power, Itanagar, District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 15/05/2023 regarding 11 KD dedicated feeder along with distribution transformer sub-station and sitting up power for Chief Minister Bungalow, State Guest House and Banquet Hall at Niti Vihar, Itanagar. Amounting to Rs. 350.00 (Three Crore fifty lakhs).

2). **The re-scheduled hearing was held on 3rd December, 2024 (Tuesday) at 1030 hrs.** Shri Tadar Rade, the PIO-cum-EE (E), Capital Electrical Division, Department of Power, Itanagar, District, Arunachal Pradesh was present and the Appellant Shri Sama Bagan was also present but arrived a little late.
