ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Palen Laa & Smt. Yukar Yaga for non-furnishing of information by the PIO, o/o the BDO, Puchi Geko, Kamle District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide application dated 14.08.2023.

This appeal is heard today on 27/09/2024 wherein both the Appellant Shri Palen Laa and the APIO, Shri Taju Tama Co-cum-BDO Puchi Geko under Kamle District, are present.

The APIO informed that the projects in question against which information(s) has been sought by the Appellant come under his Block.
