Information sought :

The appellant file a RTI Application dated 11/11/2024 seeking Details regarding Total lists of project sanctioned under Pradhan Mantri Jan Vikas Karyakaram (PMJVK), erstwhile-MsDP Scheme, Ministry of Minority Affairs Govt. of India during the financial year 2026-17.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 26/12/2024. No hearing has been conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Tamchi Gungte absent.
Respondent : PIO-cum-EE(WRD), Yingkiong Division is represented by APIO.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gungte on 11.11.2024 filed an RTI application under Form-'A' before the PIO-cum-EE(WRD), Yingkiong Division, Upper Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 26.12.2024, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 17.02.2025 and the Registry of the Commission (APIC), having

receipt of the appeal, registered it as APIC No. 172/2025 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 3 (three) time i.e on 16/07/2025, 04/08/2025 and 01/09/2025. In this hearing of the appeal on 1st day of September, 2025, the PIO-cum-EE(WRD), Yingkiong Division, Upper Siang District is represented by APIO Shri Ahing Siboh but the appellant Shri Tamchi Gungte found absent.

As per the last second hearing dated 04/08/2025, the appellant has stated before the Commission that he needs 1 (one) week time to go through the documents and will intimate to the Commission. The Commission clearly recorded in last order that if the appellant does not intimate to the Commission, the Commission will deem that the appellant is satisfied with the information provided.

Today the PIO is represented by Shri Ahing Siboh, APIO but the appellant found absent. Sufficient time has already been given to the appellant to go through the documents provided to him and was directed to intimate before the Commission but no such intimation has received from the appellant.

Therefore, the Commission deems that the appellant is satisfied with the information provided to him by the PIO. Therefore, this appeal case is deemed fit to be disposed of and closed.

The appeal case is disposed of and closed in the absence of the appellant.
