**Relevant facts emerging from appeal:**

RTI application filed on : 26.08.2024  
SPIO replied on : Not on record  
First appeal filed on : 05.10.2024  
First Appellate Authority's Order : 25.10.2024  
Second Appeal filed on : 18.11.2024

The appellant filed an RTI application dated 26.08.2024 seeking information regarding Providing lift water Supply to Ningroo Charali (under JJM).

**Details of Information:**

- Xerox copy of Detail Project Report and Sanctioned Memo alongwith First & Final bill of the said scheme.
- Xerox copy of Measurement Book of the said scheme.
- Xerox copy of Notice Inviting Tender of the said scheme.
- Xerox copy of Name of Firms along with submitted Documents.
- Xerox copy of Name of Firm who qualified in the technical bid and participated in the technical bid along with Comparative Statement.

- (f) Xerox copy of letter of acceptance and Agreement between Executive Engineer and the Firm owner.
- (g) Xerox copy of the details of Payment done through cheque / PFMS mentioned in the First & Final bill.
- (h) Xerox copy of the board members of the tender processing.
- (i) Xerox copy of Geo-tag of the said scheme, before starting and after completion of the said work.
- (j) Xerox copy of Design & drawing of the work.
- (k) Xerox copy of Utilization Certificate, Completion Statement and Completion report of the scheme.
- (l) Xerox copy of GST registration certificate, income tax clearance certificate, latest audit report of last 3(three) years duly certified / audited by the chartered Accountant of the firm who did the work/scheme.

Period of which information asked for: 2020-21.

The following were present.

**Appellants** : Present.  
He states that all information has been received but wish the information documents to be attested by the PIO /APIO. He desires to make site inspection of the project of which the information is obtained.

**Respondent PIO** : He states that the site inspection cannot be allowed citing judgement of Delhi High Court in the similar case.

**Decision:**

The commission after adverting to the facts and circumstances of the case and hearing the parties observes that all information as sought has already received by the appellant. There is no item for site inspection of the project in the original RTI application in form-A. So, there is no question of site inspection in this appeal case.

I am of the opinion that this appeal case is fit to close and dispose of.
