This is an appeal under Section 19 (3) of RTI Act, 2005 received from Shri Bengia Raju, G-Sector, Ward No.26, PO/PS- Naharlagun, Arunachal Pradesh for non- furnishing of information by the PIO-CUM-E. E, (PWD) Sangram Division, Kurung Kumey District, Govt. of Arunachal Pradesh as sought for by the Appellant under Section 6(1) (Form-A) of RTI Act,2005.

ORDER

This appeal was heard for 5(five) times on 31/01/24, 22/03/24, 07/06/24, 05/07/24 and 09/08/24.

In the first and the second hearings the PIO was absent but the Appellant was present. However, in the 3rd hearing on 07/06/24, the representative of the PIO, Shri Bini Tare, P.A to the PIO attended the hearing and handed over some of the information(s) and submitted that the rest of the information(s) requested by the Appellant could not be furnished as those were under the custody of the SIC in some other case.

In the 4th hearing on 05/07/24 the PIO was again absent.

The Appellant who was present requested for site inspection of the project besides furnishing the left-out information(s).

The Commission considered the request of the Appellant and directed the PIO, the E.E, (PWD), Sangram Division accordingly and also directed the PIO to appear in the next date of hearing fixed on 09/08/24.

In the 5th hearing the PIO was again absent. The Appellant who was present submitted that neither the left-out information(s) were provided to him nor the site inspection could be carried out as directed by this Commission in 4th hearing.

The Commission had taken serious view of the continued absence of the PIO or his representative and directed the PIO to furnish all the left-out information(s) besides carrying out Site inspection and to attend the next hearing in person and warned that if the PIO fails to comply with the direction of this Commission, necessary action under Section 20 of RTI Act,2005 shall be initiated against him.

Accordingly, the next date of hearing was fixed 06/09/24 and summon was issued to the PIO.

In the meantime, however, the Appellant Shri Bengia Raju, vide his letter dated 21/08/24, informed that he had received all the relevant information(s) as per his application dated 05/06/23 and requested for disposal of the appeal.

The Commission Perused the said letter of the Appellant and considered the request made therein and the Commission finds that no further intervention of this Commission is warranted on the appeal and as such the appeal No. 856/2023 stands disposed of and closed for once and for all.
