This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Karan Veo on **22.05.2024** filed an RTI application under Form-'A' before the PIO-Cum- DFO, Tawang, Tawang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on **27.06.2024** the Appellant, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **05.08.2024** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 221/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for Once i.e on 29.08.2024 In this hearing of the appeal on 29th day of August, 2024. The Appellant Shri Karan Veo and the PIO present during hearing.

Heard both the parties.

The Appellant stated before the Commission that the PIO has furnished the information(s) to him only for the year of 2023 not for 2021-2022 as applied in his application.

The PIO stated before the Commission and explained the matter to the Appellant that the information(s) as applied in his application are, provided to him for the year, the Project was sanctioned in 2021-2022 but the work took place in the year of 2023, because the proceeding of plantation takes times as it is done completely step by step and the payment for the works were done in 2023 to 2024.

After hearing the PIO, the Appellant accepted and admitted the misunderstanding with the information(s) provided to him by the PIO. And accordingly, the Appellant requested the Commission for disposal and closure of his appeal on the ground of satisfactorily in receipt of the information(s) as applied in his form 'A' application.

Therefore, in view of the above facts and circumstances I find this appeal fit to be disposed and closed. As both parties agreed and satisfied with judgment passed by this Court. And, accordingly, this appeal stands disposed and closed once for all.
