Information sought :

The appellant file an RTI Application dated 17/08/2023 seeking Details regarding C/o CC Pavement from main town to Donyi Polo Colony under RE Scheme Palin, Kra Daddi District..

As per the case record, PIO has never conducted hearing under his jurisdiction.

Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal on 22/09/2023.

The following were present.

Appellant : Shri Tam Rararu absent.

Respondent : PIO-cum-Executive Engineer (PWD), Palin Division present.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tam Rararu on **17.08.2023** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (PWD), Palin Division, Kra Daddi District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the Second Appeal before the Arunachal Pradesh Information Commission on **22.09.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 928/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for six times i.e on 02/12/2024, 13/01/2025, 24/02/2025, 26/03/2025 and 28/04/2025. In this hearing of the appeal on 28th day of April, 2025, the PIO-cum-Executive Engineer (PWD), Palin Division present in person but the appellant Shri Tam Rararu found absent without any intimation to the Commission.

On the last hearing dated 26/03/2025, the PIO had handed over the information sought by the appellant to him, but the appellant had stated that some of the Xerox copies of the documents not visible. The PIO had stated that the appellant can visit the office of PIO-cum-EE (PWD), Palin Division and get photo copy from the original document. The appellant was directed to visit the office of the PIO and take photograph of the documents which are not visible and clear.

Today dated 28/04/2025 the appellant is absent and he has not intimated to the Commission regarding the last order made. The PIO has brought the remaining information which are not clear and visible as per the appellant. Copy of the forwarding letter of information furnishing to the appellant is submitted.

The Commission deems that the appellant is satisfied by the information provided to him and he is no more interested to pursue the appeal case. Therefore, this appeal Case No. APIC-928/2023 is disposed off and closed in his absence. However, the appellant can collect the information sought which has already been brought today by the PIO from his office.


