## ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Palen Laa & Smti. Yukar Yaga, c/o Jullang near Sonam Nursery Po/Ps- Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum- District Agriculture Officer (DAO), Raga, District Kamle, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 14/03/2023 regarding Promotion & development of cash crop in Arunachal Pradesh & C/o Bamboo plantation under NEC of north east bamboo development council under Gepen circle.

The 1<sup>st</sup> hearing is held today on 9<sup>th</sup> May, 2024 (Thursday) at 1400 hrs. Both the parties are present. The Appellant Shri Palen Laa is present. Smty Naga Tado, (Mob:-9560202761) PIO-Cum-DAO, Kamle District, Raga is present and submitted that she had already intimated to the Appellant stating that the information sought for namely; with Promotion & development of cash crop in Arunachal Pradesh & C/o Bamboo plantation under NEC of north east bamboo development council under Gepen circle are not implemented by the Department of Agriculture, Kamle. But the Appellant is not satisfied with the reply of the PIO and appealed the Commission to furnish in affidavit. The Commission directed the PIO to furnish an "AFFIDAVIT" with justifiable reasons duly signed before the Notary Public or Judicial Magistrate which should be furnish within 20 days from the date of issue of this order failing which penal action may be initiated. However, on going through the records as available and submission of both the parties, it is found that the appeal case has not been heard by the First Appellate Authority (FAA).

As per the provisions of the RTI Act, 2005 when the information seeker does not receive any response or furnish incomplete information within 30 days from the date of receive of the application, the Appellant is requiring to file appeal to the First Appellate Authority (FAA) and First Appellate Authority (FAA) in the interest of principle of natural justice summon both the parties and give equal and fair opportunities of being heard and pass necessary order on merit.

Hence, this has been not heard in the First Appellate Authority (FAA), so the case is remanded to the First Appellate Authority (FAA) for proper hearing by giving fair opportunities to both the parties of being heard and pass appropriate action on merits.

The case is closed. Appellant is at his liberty to file fresh appeal, if he is aggrieved with the decision of the First Appellate Authority (FAA).
