JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Tamchi Gungte on **27/08/2024** filed an RTI application under Form-'A' before the PIO-Cum- Executive Engineer Hydro Power Dirang Division, District Anini, Govt of Arunachal Pradesh, whereby, seeking various information, as quoted in his Form-A application. The Appellant, being not in receipt of the information from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on **18/10/2024** Appellant, again having not received the required information despite the order from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **28/10/2024** and the Registry of the Commission (APIC), having receipt of the Appeal, registered it as **APIC No. 340/2024(Appeal)** and processed the same for its hearing and disposal.

Accordingly, the Commission sent notice for the 1st hearing and thereafter matter came up for hearing before the Court of the Arunachal Pradesh Information Commission for two times i.e on **06/02/2025 & 10/04/2025** In this 2nd hearing of the appeal on **10th day of April', 2025**. The Appellant absent with letter of absence and PIO present during the hearing through online mode. During the last hearing the Appellant had stated that he has received all the information(s) only the copy of the information, in Serial No.-11 is not legible and therefore, had asked for a legible copy of the same.

Heard the PIO.

During the 2nd hearing the PIO stated before the Commission that as per the 1st hearing order passed by the Commission, a legible copy of the said document has already been provided to the Appellant through register post on **21/02/2025**.

The Commission observes;

After hearing the PIO and ascertaining the submission of the PIO, the Commission viewed that no further hearing is required in this appeal.

Hence, this appeal stands disposed ex-parte and closed once for all.
