**JUDGMENT/ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Palen Laa & Smti Yukar Yaga on 30/06/2023 filed an RTI application under Form-'A' before the PIO-cum- District Agriculture Officer, Raga, Kamle District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 31/07/2023 Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 01/09/2023 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 858/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the **Commission for 4 (Four) times i.e. on 13.11.2023, 08.01.2024, 02.02.2024 & 08.05.2024.** In this hearing of the appeal on 8<sup>th</sup> day of May, 2024, the PIO-cum District Agriculture Officer, Raga present but the appellant Palen Laa & Smti Yukar Yaga found absent without any intimation to the Commission. In the last hearing dated 02/02/2024 also the appellant was absent.

In the order dated 13/11/2024, all the information as sought by the appellant has already been provided by the PIO before the Commission and accordingly, the appellant received the same and intimated to the Commission that the PIO furnished information without proper CTC. On that the Commission directed the PIO to furnish all the information as sought by the appellant with proper CTC, Seal & Signature of the PIO.

In the Order dated 02/0/2024, the PIO present in the hearing and intimated to the Commission that he has brought all the information as per the direction of the Commission to

hand over to the appellant but due to absence of the appellant he could not handed over same to the appellant. The appellant remained absent consecutively twice hearing on dated **02/02/2024 & 08/05/2024** without any information to the Commission .So, it is deemed that the appellant has no further interested on this case of Appeal No. APIC-858/2023.

After going through all the records in the case file it seems that all the relevant information sought by the appellant has already been provided.

In view of the above facts and circumstances, I find this appeal fit to be disposed off without hearing the appellant. And, accordingly, this appeal stands disposed off and closed once for all.
