ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Lokam Namdu for non-furnishing of information by the Block Development Officer-cum-PIO CD Block, Sarli & Polosang Kurung Kumey District, A.P as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 17.05.2023.

Brief facts:

Records in the appeal disclose that the appellant had requested for 33(thirty three) point information on implementation of schemes under SIDF/MLA LAD FUND/ UNTIED FUND under the CD Block Sarli & Polosang Circle from 2019-2020 to 2022-2023 from the BDO, CD Block Sarli and Polosang but he failed to obtain the information which prompted him to file his 1st appeal to the 1st Appellate Authority, the D.C, Kurung Kumey District, Govt. of Arunachal Pradesh, Koloriang under section-19(1) vide his Memo of appeal dt.19.06.2023. But he still could not obtain the sought for information from the PIO. Hence, this Second appeal before the Commission which was filed on 09.08.2023.

Hearing and decision:

This appeal is heard today on 09.05.2025 for the 3rd time, the earlier 2(two) hearings being on 25.09.2024 and 09.04.2025.

In the 2nd hearing on 09.04.2024, the APIO, Er. Shri Chera Nachung, PTA-cum-EO (RE) o/o the BDO, Sarli and Polosang was present in person but the appellant, Shri Lokam Namdu was absent.

This Commission, after hearing the APIO who submitted that the o/o the BDO, Sarli and Polosang did not implement any scheme/project under SIDF/MLA LAD FUND/ UNTIED FUND under the CD Block Sarli & Polosang Circle during the period mentioned in the RTI application of the appellant, had directed the o/o the PIO to furnish an affidavit declaring that no schemes/projects were implemented by the o/o the PIO on or before 09.05. 2025 as required under rule 5 (vi) of the A.P Information Commission (Appeal Procedure Rules) 2005.

In the hearing today, the appellant is present in person. The APIO is also present with the copy of the PIO's letter dt.26.03.2025 addressed to this Commission enclosing therewith the copy of letter of even dated addressed to the BDO by the APIO stating therein that no scheme/project under SIDF/MLA LAD FUND/ UNTIED FUND under the CD Block Sarli & Polosang Circle was implemented during the period mentioned in the RTI application of the appellant.

The APIO reiterating the earlier submission, stated that in view of what had been submitted, the question of furnishing the requested information does not arise.

This Commission, upon hearing the APIO and considering the contents of the said letter, is of the view that this appeal does not require any further adjudication and in view thereof, the appeal is disposed of and closed.


