## Order

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Lazala Singpho on 25.04.2024 filed an RTI application under Form-'A' before the PIO-Cum- EE,& WS Division, Bordumsa, P.O- Bordumsa, Changlang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on 27.05.2024 the Appellant, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 26.07.2024 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No. 218/2024 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for Once i.e on 29.08.2024 In this hearing of the appeal on 29<sup>th</sup> day of August, 2024. The Appellant Shri Lazala Singpho present during hearing and the APIO heard through online mode.

Heard both the parties.

The PIO stated before the Commission that on dated 26.06.2024 the FAA has conducted a hearing and passed an order that the information(s) as applied by the applicant is very voluminous and not specific and its not possible for the PIO to provide all the information within a month.

After hearing the PIO, and going through the form 'A' application of the Appellant and the order passed by the FAA, the Commission ordered;

- The PIO to provide the serial no. 1 & 2, which are information(s) pertaining to (i) UC and LOC only to the Appellant;
- (ii) The serial no. 3 may be provided to the Appellant year wise as per the convenience of the PIO.
- (iii) The Appellant to collect the information(s) of serial no. 1 & 2 from the PIO office after paying requisite fees. And accordingly, the Appellant agreed with the Commission.

Therefore, in view of the above facts and circumstances I find this appeal fit to be disposed and closed. As both parties agreed and satisfied with judgment passed by this Court. Accordingly, this appeal stands disposed and closed once for all.
