Information sought :

The appellant file a RTI Application dated 11/11/2024 seeking Details regarding Totallists of project sanctioned under Pradhan Mantri Jan Vikas Karyakaram (PMJVK), erstwhile-MsDP Scheme, Ministry of Minority Affairs Govt. of India during the financial year 2026-17.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 26/12/2024. No hearing has been conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Tamchi Gungte present in person.
Respondent : PIO-cum-EE(WRD), Pasighat Division attended through VC.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi gungte on 11.11.2024 filed an RTI application under Form-'A' before the PIO-cum-EE(WRD), Pasighat Division, East Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 26.12.2024, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 17.02.2025 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 173/2025 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 3 (three) time i.e on 16/07/2025, 04/08/2025 and 01/09/2025. In this hearing of the appeal on 1st day of September, 2025, the PIO-cum-EE(WRD), Pasighat Division, East Siang District, attended the hearing through VC and the appellant Shri Tamchi Gungte present in person.

As per the hearing dated 04/08/2025, the PIO has stated that the information as sought by the appellant is not available with the Office of the PIO-cum-EE(WRD), Pasighat Division. The PIO was directed to file an affidavit declaration to the same.

Today on 3rd hearing the PIO has submitted an affidavit on declaration regarding the non-availability of the documents as sought by the appellant. Basing upon the affidavit declaration submitted by the PIO today before the Commission, the appeal case No. APIC-173/2025 is disposed of and closed.
