ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Tapak, Lekhi Village, Near Iconic Dealer, PO/PS Nirjuli, Papum Pare District, Arunachal Pradesh for non-furnishing of information by The PIO-Cum-Dy State Project Director, Govt. of A.P., SAMAGRA SHIKSHA / ISSE ,RMSA, Itanagar, P/Pare District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 07/03/2022 regarding the details of appointment orders of PTI & PTI Grade-II, PTT, PET, PRT, TGT.

The 19th hearing was held today on 22nd July' 2025 (Tuesday) at 1100 hrs. The PIO –Cum-DDSE, Govt. of A.P., Ziro, Lower Subansiri District, Arunachal Pradesh and Shri Nabam Tapak, the Appellant, were absent.
