ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Tamchi Gungte on 28/04/2023 filed an RTI application under Form-'A' before the PIO-Cum- EE, WRD, Pasighat East Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 08.06.2023 the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 08.12.2023 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No. 653/2024 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for once i.e on 05.11.2024. In this hearing of the appeal on 5th day of November, 2024. The Appellant Shri Tamchi Gungte and the representative of PIO, Shri Yasik pertin (AE) present during the hearing.

Heard both the parties.

The representative of PIO stated that the former PIO has written a letter to the Appellant on dated 20/05/2023 that the information(s) as sought in his form 'A' application are not available under this Division. Whereas in 2019, Pasighat WRD Division was bifurcated into 2(two) Divisions namely Pasighat WRD Division and Likabali WRD Division. Hence, all information(s) related to Likabali Division were handed over to likabali Division and the information(s) related to the work which the Appellant has sought information(s) for were executed in the areas now under Likabali WRD Division

Therefore, the copy of the same letter written to the Appellant from the PIO submitted before the Commission and the same has been handed over to the Appellant.

After going through the letter provided by the representative of PIO, the Appellant has requested the Commission for disposal/closure of his appeal.

In view of the above facts and circumstances I find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed once for all.
