Information sought :

The appellant file a RTI Application dated 10/06/2024 seeking Details regarding Name and address of the Contractors/firms, payment list with money receipt, Geo-tagging certificate etc.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 26/08/2024. The FAA has conducted the hearing in this regard on 14/08/2024. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Jiten Lora absent.
Respondent : PIO-cum-DFO, Seppa Forest Division absent.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Jiten Lora on **10.06.2024** filed an RTI application under Form-'A' before the PIO-cum-Divisional Forest Officer, Seppa Forest Division, East Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **26.07.2024**, Appellant, again having not received the

required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **17.10.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 295/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for three time i.e on 05/03/2025, 05/05/2025 and 18/08/2025. In this hearing of the appeal on 18th day of August, 2025, both the parties, PIO-cum-DFO, Seppa Forest Division and the appellant Shri Jiten Lora found absent without any intimation to the Commission.

As per the case record, it is seen that both the parties found absent consecutively in the 3 (three) times dated 05/03/2025, 05/05/2025 and 18/08/2025.

Both the parties were already warned during the 2nd hearing that if they are found absent the appeal case will be decided in their absence.

The appellant found absent in the last 3 (three) hearings dated 05/03/2025, 05/05/2025 and 18/08/2025 without any intimation to the Commission inspite of giving sufficient chances. He was already warned in the last two occasions for his absence.

Therefore, the Commission deems that the appellant is no more interested to pursue this appeal case. Therefore, this appeal case is disposed of and closed.
