**ORDER**

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Ngwazosa Yobin, Gandhigram, Vijoynagar Circle, Changlang District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-ADC(Ind.), Miao Changlang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 03/07/2024 regarding **EX-Servicemen settlers of Vijoynagar Circle.**

2). **The 1<sup>st</sup> hearing was held on 18<sup>th</sup> February 2025 as scheduled.** Shri Rinchin Dorjee Thungon, the PIO-cum-ADC(Ind.), Miao Changlang District, Arunachal Pradesh appeared before the Commission's court through video conferencing. The Appellant Shri Ngwazosa Yobin was present in person.

3). The Appellant submitted that the PIO had not furnished any information as sought for by him. The Appellant also informed the Commission that the FAA did not give proper hearing under the provisions of the RTI Act 2005.

4). The PIO submitted that the information sought for by the Appellant related to period before creation of the ADC office, hence not available in his office. Therefore, the application was forwarded to the Deputy Commissioner, Changlang, Changlang District and the same was forwarded to the DLRSO Changlang district by the DC to furnish information, if available.

5). The Commission after scrutiny of the documents available and hearing submissions of both the parties, observed that the Appellant had not approached the DLRSO Changlang District. It was also observed that the FAA-cum-DC Changlang had not conducted proper hearing under the provisions of the RTI Act, 2005.

6). Therefore, the Commission referred this Appeal case back to the First Appellate Authority (FAA)-cum-Deputy Commissioner, Changlang, Changlang for conduct of an appropriate hearing, summoning the trio ; PIO-cum-ADC(Ind.), Miao Changlang District, DLRSO Changlang district and the Appellant Shri Ngwazosa Yobin. The FAA is hereby directed to conduct proper justifiable hearing and conclude the case under the provisions of RTI Act, 2005.

7). In case the Appellant is not furnished with information as sought for by him or is aggrieved by the decision of the FAA, the Appellant may approach the Commission under the provision of the RTI Act, 2005. Commission hereby decides to dispose of this case.

**Therefore, the case is hereby disposed of.**
