**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Riya Taram & Shri Takam Sakap on **17.08.2023** filed an RTI application under Form-'A' before the PIO-Cum-EE, Department of Power, Bomdila W/Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **18.09.2023** Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **08.12.2023** and the Registry of the Commission (APIC), in receipt of the appeal, registered it as **APIC No. 112/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for once i.e on 25.04.2024 & 28.05.2024. In this hearing of the appeal on 28<sup>th</sup> day of May,2024. The representative of PIO Shri Padang Camdir Teli, (Divisional Accountant) present during the hearing but the Appellants were found absent consecutively for two times without intimating the reason to the Commission for their inability to attend the hearing. Moreover, the Commission intimated the Appellant Shri Riya Taram the date of today's hearing, well in advance but he remained absent.

The representative of PIO stated before the Commission that he has brought all the information sought by the Appellants in their RTI application but due to absence of the Appellants the representative of PIO could not hand over the said information to them.

On this, the Commission seriously viewed the Appellants reluctant attitude in not complying with the direction of the Commission and hence, the Commission directed to **issue order to the Appellant** to deposit the requisite fees to the PIO's office and collect the

information from the said office immediately and hence, this appeal is closed and disposed off .
