JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Dongru Tania on **29.08.2023** filed an RTI application under Form-'A' before the PIO-Cum-District Disaster Management Officer, Tawang, Tawang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **05.09.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **09.11.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 1038/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 27/01/2025. In this hearing of the appeal on 27th day of January, 2025, the appellant present in person and the PIO-cum-DDMO, Tawang attended hearing through VC.

However, the appellant has submitted an application addressed to the Hon'ble State Information Commissioner with a request to dispose off the appeal case No. APIC-1038/2023 filed against the PIO-cum-DDMO, Tawang and stating that all the information as sought by him has been provided by the PIO and he is satisfied by the information provided.

Request made by the appellant is accepted and the appeal case No. APIC-1038/2023 is disposed off and closed once for all.
