The appellant file an RTI Application dated 16/02/2023 seeking Details regarding JAL Jiwan Mission Yojna (JIMY) in the State of Arunachal Pradesh.

As per the case record, PIO has never conducted the hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 21/03/2023. No hearing has been conducted by the First Appellate in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER


This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Lebe Lamnio on **16.02.2023** filed an RTI application under Form-'A' before the PIO-Cum-Executive Engineer (PHE & WS), Seppa Division, East Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **21.03.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **16.05.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 420/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 11 (eleven) time i.e on **26/06/2023, 03/08/2023, 04/09/2023, 16/10/2023, 04/12/2023, 22/01/2024, 01/04/2024, 10/06/2024, 29/07/2024, 02/09/2024 and 07/10/2024**. In this hearing of the appeal on **7th day of October, 2024**, both the parties present and the PIO has stated before the Commission that all the information sought by the appellant has been provided except the News Paper cutting which the advertisement of tender was published. As per the Notification dated 24/9/2019, Notification was issued by the Principal Secretary, Govt. of Arunachal Pradesh stating that mandatory e-publishing of advertisement of Central Public Procurement Portal (CPPP) and has directed that regarding publication of advertisement for procurement of works, goods & services and publish tender through Govt. e-procurement system of NIC(GePNIC)/GeM through URL link only.

It is seen that there was no publication of advertisement has been made in the News Paper. Therefore, the Commission deems fit to dispose off the appeal case No. APIC-420/2023 filed against the PIO-cum-EE (PHE & WS), Seppa Division. Accordingly, the appeal case is disposed off. However, the appellant is at a liberty to file before the appropriate authority court if he is not satisfied by the decision of this Commission.

Therefore, Commission deemed fit to dispose off the appeal case No. APIC-060/2023 filed against the PIO-cum-DLRSO, Yupia. Accordingly, the appeal case is disposed off and closed once for all.
