ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Donik Roru & Shri Dado Kagung, Jully-II Colon Po/Ps Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (PHED & WS) Kra Daadi District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 19/09/2023 regarding **ARP Jal Jeevan Mission (JJM) entire Kra-Daadi District.**

The 1st hearing is held today on 18th June' 2024 (Tuesday) at 1030 hrs. Both the parties are present. Er. Charu Sakap, the PIO-Cum-PIO (PHED & WS) Papumpare district, A.P., Itanagar is present. After having been examined it was found that the matter was not heard by the First Appellate Authority which is one of the three major tiers of RTI Act. 1st the PIO, 2nd FAA and 3rd the 2nd Appellate Authority. So, without hearing by the First Appellate Authority the Commission is difficult to execute the case. Hence, the case is remanded to the First Appellate Authority with the directions to the First Appellate Authority that in the interest of natural justice of being heard, fair opportunity must be given to both the parties and pass appropriate order of speaking order on merit.

The Appellant is asked for the information on inter-district of one financial year of 2021-2022. The Commission convinced the Appellant to seek information on Augmentation of water supply at Panya village & Amji village for the financial year of 2021-2022. The PIO should keep ready all the information for above schemes of one financial year to be furnished to the Appellant during the hearing held before the First Appellate Authority.

The case is disposed of and closed.
