ORDER

1). This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Tapak, Lekhi Village, Near Iconic Dealer, PO/PS Nirjuli, Papum Pare District, Arunachal Pradesh for non-furnishing of information by Shri Pokter Rime, the PIO –cum-DDSE, Govt. of A.P., Daporijo, Upper Subansiri District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 07/03/2022 regarding the details of appointment orders of PTI & PTI Grade-II, PTT, PET, PRT, TGT.

2). The 16th hearing was held on 11th February, 2025. Shri Pokter Rime, the PIO –cum-DDSE, Govt. of A.P., Upper Subansiri District, Arunachal Pradesh was represented by Shri Take Hali, DA. The Appellant Shri Nabam Tapak was present.

3). The representative of the PIO brought remaining information and furnished to the Appellant. The Appellant after verification of the information informed that except for the AFFIDAVIT all the remaining information has been furnished.

4). The representative of the PIO furnished Xerox copy of the AFFIDAVIT to the Appellant and informed that the original copy has been sent in the address of the Appellant through postal service. The representative of the PIO also placed receipt of the postal service as evidence before the Commission.

5). The Commission observed that all the information as sought for by the Appellant has been furnished except for the original AFFIDAVIT. Hereby, the Commission decides to dispose of the case with caution that the original copy of AFFIDAVIT should reach to the Appellant within fifteen days from the date of issue of this order, if not the Appellant should intimate to the Commission in writing for further action.

6). Therefore, the case is hereby disposed of.
