## **INTERIM ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram, RTI Secy. (ALSU), Adv. Lokam Tadam & Adv. Tap Sajan for non-furnishing of information by the PIO, o/o the Executive Engineer (PHE & WS), Anini Division, Dibang valley District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 14.08.2023.

The appeal is heard today on 8<sup>th</sup> of November, 2024 as scheduled wherein the Appellant, Shri Riya Taram is absent but the APIO, Shri Osem Mongku, A.E. o/o the E.E. (PHE and WS) Anini Division, Dibang Valley District, A.P. is present.

In default of the appellants to comply with this order, the appeal shall be disposed of and closed.
