**ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Rajesh Paron, Shri Kamin Ejing & Shri Rumbo Apang on **21.10.2023** filed an RTI application under Form-'A' before the PIO-Cum-EE Department of (Elect.) Yingkiong Division under West Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on **06.12.2024** the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **21.01.2024** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 68/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for four times i.e on **09/04/2024, 13/06/2024, 08/08/2024 & 19.09.2024**. In this hearing of the appeal on 19<sup>th</sup> day of September, 2024. The PIO present during the hearing and the Appellant heard through online mode.

Heard both the parties.

The PIO stated that; the Appellants have admitted to have obtained all the information(s) through earlier RTI application, and the PIO produced the letter submitted by the Appellants stating that the information regarding the immediate shifting of electrical utilities for widening of BRTF road from Dite -Dime to Migging BRTF Road. When the Appellants have already obtained the information(s), the need for furnishing the same does not arise

The Appellants also admitted that they have obtained the information(s) through an earlier RTI application and hence know the full details of the project.

After hearing both the parties and going through the document produced by the PIO, the Commission ordered;

- (i) To dispose the appeal as it is evident that the information(s) sought are already in possession of the Appellants.
- (ii) The Appellants to file a fresh application to the PIO if any left over documents are needed by them which they have not specifically applied in the Form 'A' for which the appeal is been heard now.

In view of the above facts and circumstances I find this appeal fit to be disposed and closed.  
And, accordingly, this appeal stands disposed and closed once for all.
