JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Solong Yangfo on **20/04/2023** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (PHED & WS), Seppa Division, East Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **02/08/2023** Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **08/09/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 874/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 7 (seven) times i.e on 13/11/2023, 11/12/2023, 29/01/2024, 29/04/2024, 17/06/2023, 12/08/2024 and 09/09/2024. In this hearing of the appeal on 9th day of September, 2024, the PIO-cum-Executive Engineer (PHE & WS), Seppa attended the Court through online mode but, the appellant Shri Solong Yangfo found absent without any intimation to the Commission.

As per the order dated 17/06/2024, the document sought by appellant has already been furnished to the appellant. The appellant was given sufficient time of 2 (two) months to go through the documents provided to him by the PIO and directed to intimate the Commission. But he failed to comply the direction of the Commission. The Commission deems that the appellant is satisfied with the documents provided to him by the PIO.
