JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri **Kamnga Ronay** on **10/09/2024** filed an RTI application under Form-'A' before the PIO-Cum- DMO Daporijo Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in their Form-A application. The Appellant, being not furnished with the complete information from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on 10/12/2024 Appellants, again having not received the required information despite the order from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 28/01/2024 and the Registry of the Commission (APIC), having receipt of the Appeal, registered it as **APIC No. 111/2025** and processed the same for its hearing and disposal.

The 1st hearing held on 6th May 2025, related to the **APIC No-111/2025**. The Appellant is represented by **Adv. Domo Boje**, during the hearing but PIO-cum DMO Daporijo found absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is preferred against him as per the **provisions of the RTI Act 2005**, which is a statutory duty binding upon the PIO.

Heard the representative of the Appellant.

The representative of the Appellant stated before the Commission that PIO has provided all the information(s) as sought by in his form 'A' application but the information(s) sought under **serial no (a) Answer Script/Answer Sheets** of all the selected candidates and wait listed candidates have not yet been provided to him till date.

The Commission hereby observes;

The issue and the subject matter of this appeal is in ditto with the APIC No 112 which is being heard by the Commission with the same Appellant and the same PIO for the same information sought by the Appellant.

After hearing the representative of the Appellant and going through the records of the Form 'A' application the Commission hereby orders;

(i) That this appeal need not be heard as the subject matter is the same with one appeal already under consideration and hearing undergoing in the Commission numbered as on APIC No 112/2025. Therefore, **APIC No 111/2025 is hereby dismissed and the same issues in the appeal pertaining with the same PIO and same Appellant will be heard in the APIC No. 112/2025.**

The Commission hereby orders;

Hence, this **APIC No-111/2025** stands dismissed and closed once for all.


