JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Riya Taram, Shri Takam Sakap and Shri Likha Tadam on **17/05/2023** filed an RTI application under Form-'A' before the PIO-cum-Higher and Technical Education, Itanagar, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **28/06/2023** Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **28/07/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 708/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 6 (six) times i.e on 09/10/2023, 29/11/2023, 22/01/2024, 10/04/2024, 12/06/2024 and 31/07/2024. In this hearing of the appeal on 31st day of July, 2024, both the parties found absent, however, however, the appellant Shri Riya Taram has sent a letter addressing to the Commission with a request to dispose off the appeal case No. APIC-708/2023 filed against the PIO-cum-Executive Engineer (WRD), Itanagar Division. The appellant has mentioned in the letter that he has got all the information sought by him from the PIO and he is satisfied with the information provided.
