ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Dongru Tania for non-furnishing of 25(twenty-five) point information regarding the expenditure and implementation on CAMPA Schemes/VRF/ARF under the DFO, Kra Daadi District by the PIO, o/o the Divisional Forest Officer (DFO) Palin, Kra Daadi District A.P as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dt.29.05.2023.

This appeal was taken up for hearing on 25.09.2024 wherein the Appellant Shri Dongru Tania and shri Najik Talit, RFO, Palin, the APIO o/o the DFO, Kra Daddi district were present.

During the hearing the APIO brought in a copy of letter Dt. 20-10-2023 addressed to the Appellant advising him to collect the sought for information from the o/o the PIO by depositing a sum of Rs. 284.00 Rupees (two hundred eight four) being the cost of stationary. The Appellant, however, submitted that he did not receive the said letter from the PIO.

Be that as it may, since the APIO had brought in the sought for information, the same was handed over to the appellant and directed him to go through and report his satisfaction of otherwise to this Commission on or before 30/10/2024.

In the hearing on 30.10.2024, both the parties were present and as directed by the this Commission, the appellant vide letter dated 30th October, 2024 informed this Commission that he has received all the sought for information from the PIO, Divisional forest Officer, Kra Daadi, Palin and he is satisfied with the information and accordingly, requested the Commission to dispose of the appeal.

In the premises above, this APIC No. 748/2023 stands disposed of and closed.
