### **JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Maye Natung, Anil Dada Jilee & Shri Simo Sangchuju on **23/01/2025**, filed an RTI application under Form-'A' before the PIO-Cum-SE, Department of Electrical Circle III Department of Power Miao, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **28/02/2025** the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **09/4/2025** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 317/2025 (Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission 1<sup>st</sup> on **24/07/2025**. In this hearing of the appeal on **24<sup>th</sup> day of July, 2025**. The Appellant **Shri Maye Natung, Anil Dada Jilee & Shri Simo Sangchuju** and the PIO both are found absent during the hearing.

**The Details for information(s) sought from the PIO**

1. Newspaper cutting of an advertisement1. made published by the concerned department, whereby they applied for the post of WC Khalasi in all grades with reference to the aforementioned vide numbers.
2. A request letter made by the concerned department to NIC State/District centre for uploading in the website of the concerned department.
3. The publicized Gazette of Arunachal Notification with the counsel of Department of Administrative Reforms, Govt. of Arunachal Pradesh, which is mandatory for Government Jobs, along with the website where it is uploaded.
4. A prayer letter which conveyed to the . Director, Department of Information, Public Relation & Printing, GoAP, Naharlagun/DPRO of the concerned district for advertising in local newspaper of Arunachal Pradesh.
5. All applicants deposited treasury challans as an applicant fee in favour of the SE (E), APEC-III, DOP, Miao/others, under the given head account.
6. Total nos of appliers, Scrutinized Board Specific date of interview along with its members, and notification of scrutiny.
7. Specific date of interview along with its venue made issued by the concerned department.
8. List of all eligible and ineligible candidates where they were.
9. The Tracking IDs of Speed post of the eligible applicants' call letters that mailed through Indian Post & entry register in case of manual, including their calling letters/admit cards.
10. Board member who took trade test/interview them including others for the post of WC Khalasi in all classes.
11. Newspaper clipping of result notification where they were in, with reference to the said order numbers.
12. The proceeding file/e file of the each above mentioned person right from initial to till closing of file, including all annexure.



13. The approval from the Chief Engineer (P), Eastern Electrical Zone, Department of Power, Itanagar/Namsai, for appointment of the each above mentioned person to the post of WC Khalasi in all categories under direct recruitment quota.
14. The recommendation letter in respect of the said persons for considering appointment to the post of WC Khalasi in all brackets under direct recruitment quota.
15. The approval from the State Government for appointment of them under direct recruitment quota.
16. The officially tabled technical qualifications of the above mentioned WC Staff serving under the EE, Deomali Electrical Division, Department of Power, Deomali.

However, the Appellants Shri Maye Natung, Anil Dada Jilee & Shri Simo Sangchuju has submitted a letter to the Commission on **18/07/2025** stating that they have received all the information(s) as sought in their Form 'A' application and have requested the Commission for disposal/closure of their appeal on ground of satisfactorily in receipt of all information(s) sought from the PIO.

In view of the above facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed off and closed once for all.
