#### Information sought:

The appellant filed an RTI application dated 30.06.2023 & 19.08.2023 seeking following information Regarding up-to-date details of the Old Water Supply Tanks under PHE and W/S department in Lekang CD Block.

Details of information required: -

a. Furnish in details of old water supply tanks (villages like kaupatoni, Sengapather, Kumari, Adivasi, Kathalguri, Upper Silato, Mahaloni, Eraloni...etc.) wherever constructed before LWS under JJM schemes in Lekang CD Block.

b. Furnish in details of demolished/repaired/auctioned process (if any) of list of Old Water Supply Tanks village wise under lekang CD Block.

The first appellate authority has heard the first appeal on 25.10.2024. He has directed appellant to specify the information sought for one financial year.

The following were present.

**Appellant** 

Present through VC.

He states that the information disclosed to him is misleading and is not accountable. He wished to make a

site inspection.

**Respondent PIO** 

Present.

He states that the information sought for the period from 2010 to 2023 is not available. He has conveyed this to the appellant in writing vide letter no. **ND/PHE/W-19/2023-24/1949** dated 29.09.2023.

On interjection the appellant has confirmed that he has received letter no. **ND/PHE/W-19/2023-24/1949** dated 29.09.2023 from the PIO.

#### Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing observes that the PIO has conveyed to the appellant in writing the non-availability of information in his office. The PIO has confirmed in his statement today in this commission court that the information sought "Seeking information of up to date details of the Old Water Supply Tanks under PHE and W/S department in Lekang CD Block" for the period from 2010 to 2023 is not available in his office.

I am of the opinion that since the PIO has clearly stated that the information sought is not available in his office, it is fit case to close this appeal case.

The appeal case is closed and disposed of accordingly at commission.
