JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Kina Tarin on **10.10.2023** filed an RTI application under Form-'A' before the PIO-Cum- Principal Chief Conservator of Forest, Department of Forest, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **08.12.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **24/01/2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 64/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on **13.03.2024**. In this hearing of the appeal on **13th** day of March, 2024. Both the parties found absent during the hearing, however, the PIO has detailed his representative. The appellant is directed to file before the F.A.A for the information under Section 6 of RTI Act which he is seeking. The FAA-cum-PIO is directed to take up case and dispose as per Section-7 of RTI Act, 2005 within 30 days on receipt of the request.

The Commission found that the case has not been done through proper procedure, I find this appeal fit to be disposed of and closed. And, accordingly, this appeal stands disposed off..
