## JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Gatung Nabam on 25.03.2023 filed an RTI application under Form-'A' before the PIO-cum-DLRSO, Lemmi, Pakke Kessang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 04/05/2023, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 06/06/2023 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 537/2023 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 6 (six) times i.e on 14/09/2023, 30/10/2023, 11/12/2023, 22/01/2024, 01/04/2024 and 10/06/2024. In this hearing of the appeal on 10<sup>th</sup> day of June, 2024, the PIO present but the appellant found absent without intimation to the Commission.

During the hearing the PIO submitted an Affidavit and stated that I am DLRSO, Pakke Kessang District, Lemmi he has furnished documents to Shri Gatung and received by Nishan Nabam alias Ashok Nabam on 11/12/2023 in the Commission Court, Itanagar. The documents furnished to the appellant, true and certified copy which available in the District DLRSO Office, Pakke Kessang. And the PIO has already stated on affidavit the has provided all the information to the appellant, it is seems that there is no more documents to be provided to the appellant.

Moreover, as per the case record the appellant of the case is Shri Gatung Nabam and not Ashok Nabam. The appellant is found absence for the last 6(six) hearing i.e., dated 14/09/2023, 30/10/2023, 11/12/2023, 22/01/2024, 01/04/2024 and 10/06/2024.

In view of the above facts and circumstances, I find this appeal fit to be disposed off. And, accordingly, this appeal stands disposed off and closed once for all.
