JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Buli Bhai on **10/04/2023** filed an RTI application under Form-'A' before the PIO-Cum-Executive Engineer (PWD), Khonsa Dvision, Tirap District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **10/05/2023**. Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **17/08/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 778/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 10 (ten) times i.e on 09/10/2023, 29/11/2023, 08/01/2024, 02/02/2024, 01/05/2024, 19/06/2024, 12/08/2024, 09/09/2024, 11/11/2024 and 10/02/2025. In this hearing of the appeal on 10th day of February, 2025, the PIO-cum-Executive Engineer (PWD), Khonsa Division and appellant, Shri Tamchi Gungte found absent. However, the appellant has submitted an application addressed to the Hon'ble State Information Commissioner stating that he has received all the information as sought and he is satisfied by the information provided and requesting to dispose of the appeal case No. APIC-778/2023.

The Commission accepted the request and appeal case No. APIC-778/2023 is dicposed off and closed once for all.
