The PIO cum EAC i/c ADC, Daporijo Shri Tanam Kyali did not appear. The appellant Shri Tajum Dadi appeared.

Heard the party present.

The appellant has submitted that in spite of the orders of the commission the information has not been furnished to him by the PIO and prayed to the commission to take appropriate action against the PIO.

On perusal of the case records, it is seen that the PIO was imposed penalty of Rs 25,000/- for the delay in furnishing the information and compensation of Rs 5,000/- to be paid to the appellant.

It is also seen that PIO has written a letter to the appellant on 08<sup>th</sup> Sept'2023 informing him for collection of the information/documents from the o/o the Deputy Commissioner, Daporijo on working days.

Whereas during hearing on 15<sup>th</sup> Sept' 2023 the PIO's representative Shri Tapak Rakmi, DPO and appellant were present. On this day the appellant was asked if the said letter of 8<sup>th</sup> Sept' 2023 from PIO was received by him. The appellant did not reply clearly.

Today the appellant was again asked whether he received the letter dated 8<sup>th</sup> Sept'2023 from the PIO and the letter available in the commission was shown to him. He has stated that he has not received the letter till today.

A copy of letter from PIO to appellant dated 8<sup>th</sup> Sept'2023 be furnished to the appellant. The appellant shall approach the o/o the Deputy Commissioner, Daporijo for collection of information documents sought by him along with copy of this order be delivered to the PIO and obtain acknowledgement of receipt. The PIO is directed to furnish the information and also comply this court order by depositing penalty of Rs 25,000/- to the bank through treasury challan and pay compensation to the appellant.

The PIO should present in person on next date of hearing. Non-compliance of order entails bringing the matter to the notice of the higher authority who can take action against the PIO and shall invoke Section 20 (2) of the RTI Act, 2005 against the PIO.

The case is adjourned to 10.06.2024 at 02:00 PM.
