First Appellate Authority's Order	:	Vide letter dated 30.09.2024, PIO O/o DC, Tezu has requested the PD (RD) Tezu, to furnish the information sought in Form A.

Information sought: The appellant filed an RTI application dated 01.08.2024 seeking following information: -

Details of information Required:

- i) Detailed of peon, driver, Comp.Assistant, Typist and seniority lists of LDC of DRDA Lohit Distt. Tezu.
- ii) Furnish the detail information in promotion of above mentioned post i,e LDC, peon, driver, Comp. Assistant and Typist which include HA promotion of date year and time from 2022 to 2023.
- iii) Furnish the detail of advertisement order No. date, year and appointment order No. Govt. post creation order No. seniority list of LDC order No.

Period from which information asked for: 2022 to 2023.

The following were present.

Appellant : Present.

In today's hearing the appellant states that the sought information is not furnished to him irrespective of direction issued by FAA – DC Tezu on 30.9.2024 for furnishing the information to the appellant.

Respondent PIO : APIO Shri Kirli Bui, APO represented the PIO through VC. He states that appellant has not written proper address of the PIO and the FAA has not heard the appeal. On interjection he has assured to furnish the information as sought in the RTI application in form – A.

FAA : Absent

Decision:

The Commission after adverting to the facts and circumstances of the case, hearing the parties and perusal of the records, observes as follows:

- 1) The applicant has submitted RTI application to the Project Director, DRDA Tezu. Contrary to claim of the APIO, the address to PIO seems to be correct. Otherwise also the application has already been received at PD DRDA, Tezu office.
- 2) FAA – Deputy Commissioner, Tezu has already taken action on first appeal by directing PIO – PD DRDA with written letter dated 30.09.2024. The appearance of FAA – DC Tezu is exempted from further hearing on this appeal.
- 3) PIO – PD DRDA, Tezu is directed to furnish the information sought to the appellant within 30 days from the date of issue of this order i.e. on or before 23.02.2025.
- 4) The appellant shall serve a copy of this order to the PIO and obtain written acknowledgement and submit a copy of it to this commission.

Hearing adjourned. Next date of hearing shall be fixed on receipt of compliance report from Appellant.
