This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Ram Veo, C/o Advocate Nayam & Associate, Itafort Shopping Complex, Itanagar for non-furnishing of information by the SPIO-cum-EE(PHE & WS), Govt. A.P., Yingkiong Division, PO/PS Yingkiong, District Siang, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 28/02/2023 regarding Compensation of water supply or damage estimate / amount of Ditte-Dime-Migging Road Package-I to package-IV, for construction / Improvement of Road to NHDL Specification.

The 8^{th} hearing was held today on 5^{th} November 2024 (Tuesday) at 1030 hrs.

Both the parties were present in the court hearing. Shri Atit Miyu, AE represented the PIO-Cum-EE (PHE & WS), Yingkiong Division and Shri K. L. Nayam, Advocate represented the Appellant.
