JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Chow Lajamang Mannow on 12/9/2024, filed an RTI application under Form-'A' before the PIO-Cum- ES (PWD) Jairampur Circle Jairampur Changlang District Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 12/10/2024, the Appellant, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 6/02/2025 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No. 125/2025 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission two times i.e on 01/05/2025, & 29/07/2025, details of information(s) sought from the PIO.

Details of Information:-

- i) Category of Work charge (W/C) Serving under your Circle.
- ii) Appointment Letter of all the W/C staff serving under your Circle
- iii) Place of Posting of all the W/C staff serving under your Circle.
- iv) Approval from competent Authority CE or SE, Advertise details, Interview or Viva Det along with board formed then details of all the W/C staff recruited under your Circle
- v) Present Strength of W/C staff under your Circle.
- vi) New Strength or Against Retirement or Vacate of W/C staff under your Circle.
- vii) Total Sanction Strength of W/C staff under your Circle.
- viii) Period for which information asked for:- 2020-till date.
- ix) A fee of 20/-1 has been deposited in the office of the competent authority vide Treasury / IPO No. 086 926409

In the final hearing on 29th day of July'2025, the Appellant absent, the Plo present through online mode.

However the Appellant Shri Chow Lajamang Mannow, submitted a letter to the Commission on **27/6/2025** stating that he has received all the information(s) as sought in his Form 'A' application and has requested the Commission for disposal/closure of his appeal on ground of satisfactorily in receipt of all information(s) sought from the PIO.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
