ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tago Kochung, Village- Yoroko, Po/Ps-Mechukha, Shi-Yomi District, Aruachal Pradesh, for non-furnishing of information by the PIO-cum-EE (PWD), Govt. of A.P., O/o Public Works Department, Mechukha, Shi-Yomi District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 24/05/2023 regarding C/o Road from BRF Road Karo to Pidi Circle.

The 3rd hearing is held today on 25th June'2024 (Tuesday) at 1030 hrs. Er. Ree Taso, JE-Cum-APIO (PWD) represented the PIO. The Appellant Shri Tago Kochung is absent. During the 2nd hearing the PIO was absent and was issued Show Cause Notice and in his reply to it submitted that during the General Election and Assembly election he was deputed in the election duty. So, could not attend the court hearing. Regarding, information as sought for it is submitted that the information are kept ready in the month of February' 2024 and intimated to the appellant for collection of the information from the office of the PIO vide No. MD/Works/RTI/2023-24/334 Dated 5/2/224, but the Appellant did not collect the information as on date.

From the records available with the Commission, it is found that certain information has already been furnished to the Appellant during the 1st hearing held on 30th January' 2024 and was asked to choose one scheme for one financial year. He has chosen for financial 2021-2022. Accordingly, the PIO had collected the information and kept ready to furnished the information seeker. Since the Appellant is absent, in view of the directions of the Commission, the case is disposed of with the direction to the PIO to furnish the information, if appellant visits his office for collection of the information.

Hence, the case is disposed of and closed.
