JUDGEMENT ORDER

Brief fact of the case is that the appellants Miss Bengia Mama on 07.09.2024 filed an RTI application under Form-'A' before the PIO-cum-Assistant Director, Textile & Handicraft, Pasighat, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 01.11.2024, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 01.12.2024 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 420/2024 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on 28/05/2025. In this hearing of the appeal on 28th day of May, 2025, both the parties, PIO-cum-Asstt.
