**ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Takar Jomoh on **16/02/2024** filed an RTI application under Form-'A' before the PIO-Cum- DLRSO Namsai, O/o the Deputy Commissioner Namsai, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **09/01/2024** the Appellants, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **07/12/2023** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 132/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for four times i.e on **16/5/2024, 22/8/2024, 01/10/2024 & 21/11/2024** In this hearing of the appeal on **21<sup>st</sup> day of November, 2024**. The Appellant Shri Takar Jamoh and the PIO present during the hearing .

However, the Appellant Shri Takar Jamoh, has stated before the Commission on dated **21/11/2024**, he has received some of the information(s) form the PIO .However, though he has not received complete information(s) form the PIO, he has requested the Commission for disposal/closure of his appeal.

In view of the above facts and circumstances I find this appeal fit to be disposed off and closed. And, accordingly, this appeal stands disposed off and closed once for all.
