Information sought :

The appellant file an RTI Application dated 31/07/2024 seeking information regarding construction of wire rope suspension bridge over Sile River at Ledum village, East Siang Distret. AP.

As per the case record, PIO did not provide the information as sought by the appellant.

Being dissatisfied, the appellant filed First Appeal dated 11/09/2024. First Appellate Authority has conducted the hearing on 08/10/2024.FAA conducted the hearing under his jurisdiction and dispose the case on non appearance of the appellant on the date of hearing by a speaking order dated 08/10/2024.

Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gungte filed on 31/07/2024 filed an RTI application under Form-'A' before the PIO-Cum-EE RWD Pasighat Division, East Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, on nonreceipt of the information from the PIO, filed the First Appeal before the First Appellate Authority on 11/09/2024.

Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 11/11/2024 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 318/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) time i.e on 05/03/2024, and 05/05/2024. In this hearing of the appeal on **2th day of May, 2024**, appellant present and PIO found absent, however the appellant submitted an application requesting to dispose the case as he has received all the information sought by him..

The Commission deems that the appellant is satisfied by the documents provided to him. Accordingly, the appeal case No.APIC-318/2024 filed against the PIO-cum- EE RWD Pasighat, East Siang District is disposed off and closed.
