JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Nabam Tapak on 09/03/2023 filed an RTI application under Form-'A' before the PIO, Office of the Directorate of Elementary Education, Govt. of Arunachal Pradesh, Itanagar whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 01/05/2023 Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 22/06/2023 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 581/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the **Commission for 5 (Five) times i.e.** on 16.10.2023, 04.12.2023, 22.01.2024, 11.03.2024 & 03.06.2024. In this hearing of the appeal on 3rd day of June, 2024, the PIO, Office of the Director, Elementary Education present but appellant Shri Nabam Tapak found absent without any intimation to the Commission. In the last hearing dated 11/03/2024, the appellant was also absent.

In the order dated 22/01/2024, all the information as sought by the appellant has already been provided by the PIO before the Commission and accordingly, the appellant received the same. The appellant found absent consecutively twice hearing on dated 11/03/2024 & 03/06/2024 without any information to the Commission and also failed to intimate satisfaction or dissatisfaction of the documents with the Commission. So, it is deemed that the appellant is satisfied with the documents provided by the PIO.
