## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Khunkam Pansa on **19.07.2023** filed an RTI application under Form-'A' before the PIO-Cum-Executive Engineer (RWD), Longding Division, Longding District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **25.08.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **29.09.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 939/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 7(seven) time i.e on 18/12/2023, 19/01/2024, 01/04/2024, 10/06/2024, 29/07/2024, 02/09/2024 and 07/10/2024. In this hearing of the appeal on **7<sup>th</sup> day of October, 2024**, both the parties present and the PIO has stated before the Commission that all the information sought by the appellant has been provided and the information which are not provided in hard copy and not at all provided has been explained and given sufficient reasons by the PIO. The building was constructed for Police Department and Executing Agency has handed over the building to SP, Longding District on 24/06/2022. The Commission is satisfied by the submission made by PIO.

Considering the merit & facts of the case, the Commission deemed fit to dispose off this appeal case.


