The appellant file an RTI Application dated 21/07/2023 seeking Details regarding Chief Minister Sevak Shiksha Yojana) of entire Kamle District.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 03/08/2023. No any hearing has conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Palen Laa & Smti Yukar Yaga on **01.07.2023** filed an RTI application under Form-'A' before the PIO-cum-Dy. Director of School Education, Raga, Kamle District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **03.08.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **04.09.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 862/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for three times i.e on 11/11/2024, 10/02/2025 and 24/03/2025. In this hearing of the appeal on 24<sup>th</sup> day of March, 2025, the PIO-cum-Dy. Director of School Education present in person but the appellant Shri Palen Laa Smti Yukar Yaga found absent without any intimation to the Commission.

In the last hearing, the appellant was directed to appear in person before the Commission in the next hearing i.e., on today 24/3/2025. If he is found absent the appeal case will be decided ex-parte and decided in their absence.

The appellant is consecutively absent for the last 3 (three) hearings on 1<sup>st</sup> hearing dated 11/11/2024, second hearing 10/02/2025 and third hearing 24/03/2025.

The Commission deems that the appellant is no more interested to pursue this appeal case. Therefore, this appeal case is disposed off and closed in absence of the appellant.
