ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Teli Naga, Vice President (Pro) Arunachal Law Students Union (ALSU) P.O/ P.S- Banderdewa District, Papum Pare, AP, for non-furnishing of information by the PIO O/o the Chief Engineer PMGSY, ARRDA, RWD Itanagar, Govt. of Arunachal Pradesh, as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

Hearing and decision:

This appeal was heard on 19/06/2024 as scheduled wherein the Appellant attended the hearing through V.C and the PIO attended in person.

During the course of hearing the Appellant submitted that he had approached the First Appellate Authority, the Chief Engineer PMGSY, ARRDA, RWD. Itanagar (A.P) quite a few times after filing the 1st appeal but no action has been taken by the First Appellate Authority and as such, he was compelled to file this second appeal before the Commission.

This Commission took up the appeal and accordingly, fixed the next date of hearing on 26/07/2024. However, in the meanwhile, the appellant, vide his letter dt.04.07.2024 addressed to this Commission, intimated that he has received all relevant documents as sought for by him vide his application dt.21.04.2023 from the PIO, the O/o the Chief Engineer PMGSY, ARRDA, RWD Itanagar, Govt. of Arunachal Pradesh and requested for disposal & closure of his appeal , APIC-642/2023.

In the premises as above, this Appeal APIC No.643/2023 stands disposed of and closed and accordingly the hearing fixed on 26.07.2024 and the summon order thereof stands cancelled.
