ORDER

This is an appeal under Section 19 (3) of RTI Act, 2005 received from Shri Chow Lajamang Mannow for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (E) Anini Electrical Division, Dibang Valley Distt., Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 02.11.2024.

A) Particular of information: Replacement of damaged HT/LT pole and conversion Of HTOH/ LTOH with ABC under Dibang Valley District under R.E. – 2023-24 (S.A.S.C.I)

B) Details of information:

11. Certified copy of documentary Evidence that have executed similar nature of work win equivalent amount in a single order commensurate to the Tender package the last 3 (three) years.
12. Certified Copy of Experience Certificate to authenticate such execution from competent authority.
13. Certified Copy of GST registration certificate, Manufacture/Dealership
14. Certified Copy of Income Tax & Sale Tax clearance certificate, latest Audit report of last 3 (three) years duly certified / Audited by the Chartered Accountant of the firm who did the work/scheme.

15. Certified Copy of Measurement Book of the said work.
 16. Certified Copy of First and Final bill of the said work.
 17. Certified Copy of Cash Book Statements with page numbers or Give hand receipt with Payee name of the said work.
 18. Certified Copy of Details of Payment done through cheque/ PFMS as mention in the First & final bill.
 19. Certified Copy of Photograph with Global Positioning System (GPS) Co-ordinates/Geo-tag of the said work, before starting and after completion of the said work/scheme.
 20. Certified Copy of Design & Drawing of the work/scheme.
 21. Certified Copy of Utilization & Completion Certificate of the said work/Scheme.
 22. Certified Copy of Name of EE/AE/JE who executed the said work/scheme/project.

Brief facts emerging from the appeal :

Records emerging from the appeal disclose that the Appellant, Shri Chow Lajamang Mannow had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the CE (P) Govt. of A.P Eastern Electrical Zone, Namsai, the First Appellate Authority under Section 19 (1) of RTI Act, 2005 vide his Memo of Appeal dated 23.12.2024. However, the appellant failed yet again to obtain the information and therefore, he preferred 2nd appeal before this Commission under Section 19 (3) of the RTI Act, 2005 vide his Memo of Appeal dated 24.02.2025.

Records also reveal that the FAA on being approached by the appellant under section 19(1) of the RTI Act, had vide letter dt.06.01.2025, requested the EE (E), Anini to intimate the o/o the FAA whether the appellant was provided with the information sought by him to take a decision for conducting hearing by the FAA. Such procedure adopted by the FAA, was not what the RTI regime mandates under section 19(1) of the RTI Act. In other words, the FAA, instead of adjudicating on the appeal filed before him by summoning the parties (both the appellant and the PIO) for hearing, had unnecessarily asked the PIO to intimate whether the requested documents had been provided to the appellant. Be that as it may, the 2nd appeal having been filed and registered in this Commission, is accordingly, listed and heard today on 28.05.2025 wherein the PIO, Er. Shri Kirdo Loya, the EE appeared through VC and the appellant attended in person.

This Commission, upon hearing the PIO, who submitted that the requested documents are ready for furnishing to the appellant, directs him to provide the same to the appellant within 1(one) month from today. The appellant is also directed to intimate this Commission of the receipt of the documents within 1(one) week thereafter failing which this appeal shall stand closed.
