**Appeal under section 19(3) of RTI Act, 2005**  
**Case No. APIC- 09/2024.**

**RESPONDENT** : The PIO, o/o Executive Engineer (PWD), Doimukh  
Division, Papum Pare District (A.P)

**ORDER**

This is an appeal under section 19(3) converted from Complaint under Section 18(1) of RTI Act, 2005 received from Shri Tania June for denial of information by the PIO, o/o the Executive Engineer (PWD), Doimukh Division, Papum Pare District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 12.09.2024.

The appellant had sought for the following information:

- i) Particular of information:  
Details of present staff under Group B / Group C/WC T / WC R / UDC / LDC / PEON / Driver / Contingency / all MTS Post etc. Give the document of all employees currently working in your office establishment.
- ii) Details of information required:
  1. joining report copies;
  2. Class X Pass certificate copies;
  3. Seniority list copies;
  4. Appointment order copies;
  5. Scheduled Tribe (ST) Certificate copies and
  6. Class XII Pass certificate copies.
- (iii) Period from which information asked for: 2018 to till date.

This appeal was heard for two times on 18.12.2024 and on 29.01.2025.

In the 1<sup>st</sup> hearing on 18.12.2024, this Commission, after hearing the parties, had converted the complaint u/s 18 to appeal under section 19(3) of the RTI Act and passed the following direction:

*“ This commission is, however, inclined to hold that the PIO ought to have given notice to the third party(s) allowing the third party(s) to make representation against proposed discloser and thereafter only, should have made an appropriate decision either to disclose the information or otherwise as mandated under section 11 of the RTI Act.*

*The procedure as above having not followed by the PIO, this Commission, in the fitness of things, directs the PIO to re-visit the matter and take appropriate action regarding the disclosure of ST certificate and educational certificates but shall furnish the copies of appointment orders and joining reports.*

*As regard seniority list of group-B,C & D staff (Sl. No-3) engaged under the division, the PIO shall obtain the same from the o/o the S.E (PWD) (Co-ordination) / S.E (PWD), Capital Circle and furnish to the appellant.*

*The PIO shall, accordingly, comply with the above direction within one month from the date receipt of this order and in any case, before the date of next hearing which is fixed on 29.01.2025."*

In the hearing on 29.01.2025, the representative of the PIO, Er. Shri Tayo Bagang, AE and the appellant, Shri Tania June were present and the representative of the PIO brought in the information relating to the group-C staff under the establishment of the PIO's Division which have been handed over to the appellant. But as regards the information relating to Group-B staff, the representative of the PIO submitted that as directed by this Commission, the o/o the PIO, vide letter dt.26.12.2024 had requested the o/o the Superintending Engineer (PWD), Coordination Capital Circle to furnish the sought for documents pertaining to the Gr-B staff which are available with them, but o/o the S.E has not yet responded to the said letter. He, therefore, sought some more time to collect the information from the o/o the S.E, Coordination.

This Commission, upon hearing the parties and on perusal of the documents brought in by the PIO's representative which appear to be satisfactory, directed the representative to collect the left out information from the o/o the S.E, Coordination and furnish to the appellant within 1(one) month from the date of receipt of Commission's order dt. 29.01.2025 and in any case, before the next date of hearing which was fixed on 5<sup>th</sup> March, 2025. The appellant was also directed to intimate his satisfaction or otherwise with the information so received from the PIO before the next hearing.

As scheduled, the appeal was listed on 05.03.2025 wherein the APIO, Shri Tayo Bagang is present with the remaining information but the appellant is absent without any intimation.

Heard the APIO who submitted that he had contacted the appellant who informed that he will collect the information from the o/o the PIO.

This Commission, accordingly, directs the APIO to hand over the information to the appellant and this appeal, thus, stands disposed of and closed.
